

PARKING ENFORCEMENT

Parking Ambassadors will monitor all public parking on a rotating schedule within Downtown Mesa between the hours of 8 a.m. and 5 p.m. Monday through Friday to ensure enforcement of all parking ordinances and to provide more surveillance and additional vehicle security and personal safety.

COURTESY CITATIONS

A courtesy citation may be issued for exceeding the posted time limits in customer zones for time violation at the discretion of the parking monitors. Beyond the one hour grace period that a courtesy citation provides, a citation with a penalty will be issued.

PARKING ORDINANCES

The following ordinances are currently enforced in Downtown Mesa in addition to all normal parking ordinances:

PAYMENT INFORMATION

A long-term permit payment structure has been established for employees who choose to park in restricted spaces.

Billing statements will be mailed by the 20th of each month and payment is due by the 10th of the following month. If payment is not made by the due date, the parking permit shall become invalid (Mesa City Ordinance 10-5-1 (F)1).

To cancel your permit, please email parking@downtownmesa.com prior to the next month's billing. You will receive email confirmation that your permit is cancelled.

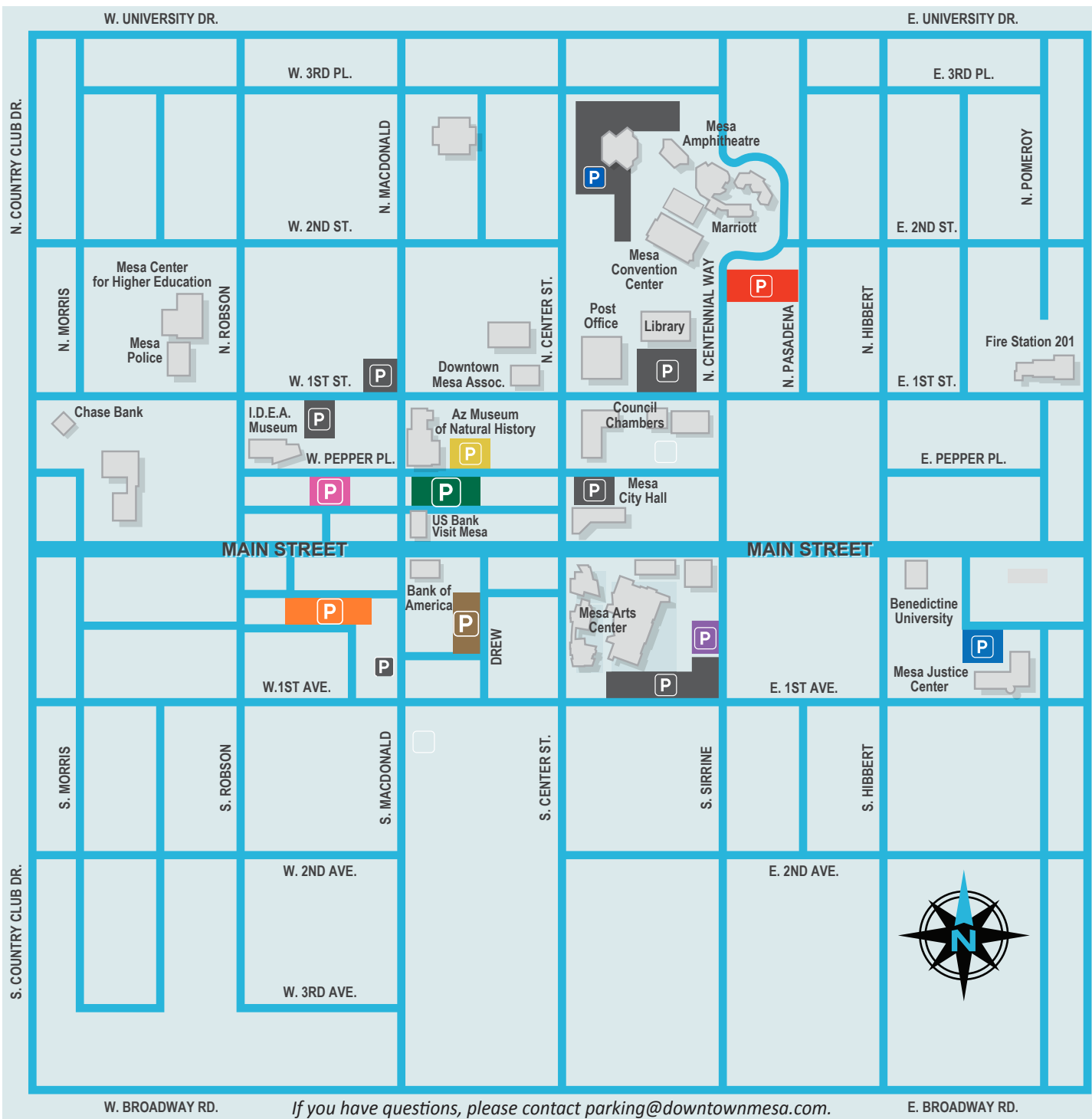

EMPLOYEE PARKING FAQ

- Q:** Who needs a parking permit?
A: If you work in Downtown Mesa and park in a city-owned lot for more than three hours, you will need a parking permit.
- Q:** What should I do if I own more than 1 car?
A: You may register up to 5 cars on 1 permit, but only 1 car may be on the premises at a time.
- Q:** How are parking rates determined?
A: Rates are determined by Mesa City Council.
- Q:** How is parking enforced?
A: The City of Mesa utilizes an electric vehicle. The cameras mounted on top read license plates to automatically confirm permits and timed parking spaces.
- Q:** Why can't I back into a spot?
A: The cameras located on the electric vehicle must be able to read your license plate in order to verify your permit.
