Sorry I am still catching up on emails from the holidays. I believe Krystal already responded but feel free to review the proposed pedicab locations with EVA and provide EVAs recommendation at an upcoming DPMG meeting. If you have any questions feel free to reach out. I attached the map of existing and proposed pedicab locations. Please note that the location on the northwest corner of Ninth Avenue and J Street is no longer recommended. In light of AB 413, this location will require red curb and therefore is no longer available for a pedicab resting space. All other pedicab locations identified do not result in any parking loss and have been vetted with our Fire Department.

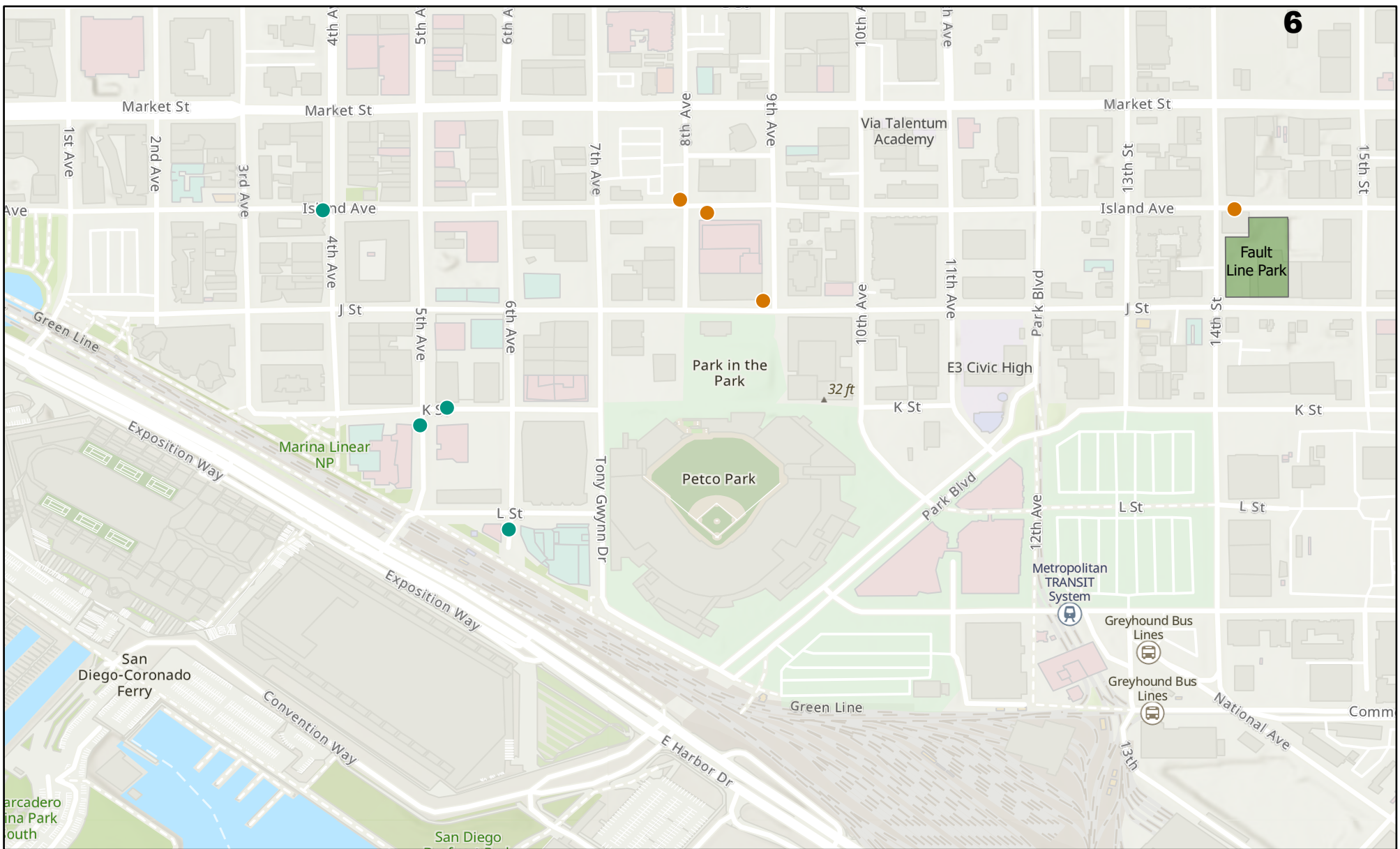

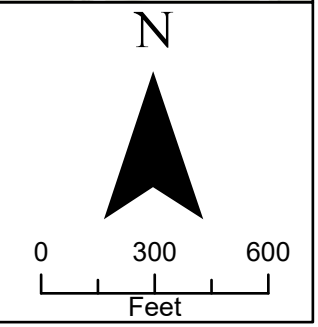
Existing and Proposed Pedicab Spaces in Downtown
