K. Brown said she is the interim manager for Bird. She has taken on the position since the exit of the previous manager. They are seeking to boost their visibility. They have new parking partnership opportunities in front of their area. Nancy is their General Manager. They can create the scoots carols to the demand of the tenant. They want to increase their presence in the neighborhood. She said that Lyft, Bird, Spin in UCSD



campus, and Wheels are the main rideshare and scooter companies in town. She said most scooters will be from Lyft and Bird.

D. Dee Snow - Barbara Bree Representative

D Snow talked about Barbara Bree chair second to Ms. Gomez. Bree wants input from the board and community. Her push is for community and neighborhood invovlement, She said Bree has spearheaded removing scooters from the board walks. She is about local enforcement, especially Airbnb.
