4:06 PM- Brittney- Council 1 approved race & equity unanimously. Informational report, shelter to home has connected 600 people to homes and 200 are in the pipeline. They are thinking of moving out of the convention center. They were funded until October, but will extend past that and 300 people into beds through December.

Brittney: In September we extended the outdoor expansion to salons, religious organizations and gyms. Expansion is good for 12 months. The quality of life in East Village has been spoken about. We have been receiving regular reports that are made to council members. We met with the police chief and are working with local partners and clean and safe to help address these issues.

C. Presentation- Marshall Anderson- Downtown San Diego Partnership

Marshall: & Daniel Reeves with Juniper. Presenting a premiere wayfinding tool through IKE Smart cities. Enables navigation. We would love a support letter when we take the project to the city and it goes before council.

Brian: This tool is very customizable to location. No cost to the city. Revenue comes from Advertising sales. No data gets collected either.

Marshall: There will be no cost or maintenance to Downtown San Diego Partnership. In fact they will receive revenue that can be put forth toward operations and be given to BIDS.



Brian: No business can pay to be listed at the top of any of the wayfinding applications.

Marshall: We are working with IKE to get customized applications that are relevant to downtown San Diego. Looking to integrate civil resources.

Brian: We are also working to make these accessible to the visually impaired and those in wheelchairs.

Marshall: We can market events and small businesses. Other areas who implemented the wayfinding tool saw an 80% increase in foot traffic to brick & mortar establishments.

Brian: Phase 1 is to get city approval on programmatic basics. We will go out to community and property owners and ensure we comply with the needs of the community. On October 28th we will be going to the economic development committee. In November and December we have a council hearing then quarter 1 of 2021 we will try to start construction.

James: Will these be at light rails or at transit areas?

Brian: We mix them throughout the city for accessibility.

James: How many will be put out?

Daniel: We will start with 25-50 throughout 270 city blocks.

James: Where will these be placed?

Daniel: They will be in the public right of way areas.

Todd: Will it be affordable to small businesses?

Brian: We will have 8 loop slides to advertise local events, restaurants and during COVID we provide reduced rates for AD loop.

Simon: Is the idea to brand them with each district?

Marshall: Yes, we can wrap them with these and put co branding as well.

Simon: Motion to support and provide letter, David 2nd, All in favor 4:14 PM

D. Alonso Vivas - Clean and Safe-4:13 PM

Alonso: We conducted our homeless count. The number went up from 559 in august to 719 in September. There were 326 in August and 447 in September in East Village alone. 447 were within a 3 block radius of the soint east, the north east sector has 58 and there were 57 in the north west region of East Village. In the south west sector we had 22. We have seen a concentration of 300 people in the south east and we are keeping an eye on this area. We will be conducting more homeless outreach. We have a meeting this morning with the Imperial Group to get updates from the city, the padres team, and environmental services. We really need businesses and residents to use the get it done app. Our team is spending a lot of time cleaning, providing security and advocating. The family reunification program



ended with 38 people traveling to the support system. We are trying to get people to transition out of homelessness. For those at the convention center we are also offering family unification.
