NOTICE OF PARKING CHANGE

May 9, 2024

Dear Property Owner and/or Resident,

The City of San Diego is proposing to install metered two-hour time limit parking on the east side of Third Avenue between Beech Street and Ash Street. This proposal is intended to create parking turn-over in the area and to increase the available on-street parking for nearby businesses and residents. This will provide better management of parking in the area and can make it easier for visitors and patrons to find parking in the area.

A parking study was conducted recently to determine the parking utilization and duration along the segment of Third Avenue. The study concluded that the east side of Third Avenue between Beech Street and Ash Street average duration per parker was 5.7 hours. We also observed 107% occupancy as vehicles were observed parking in unmarked parking spaces. Metered parking signs will help to better define areas of parking.

The effective hours of the proposed metered two-hour time limit parking along Third Avenue are between 8am and 6pm, Monday through Saturday, Sundays and holidays are excluded. This allows for use of parking in the evenings for residents in the area and is similar to metered parking hours nearby.

In accordance with Council Policy 200-04, this proposal will be discussed at an upcoming community parking district meeting. The Downtown Parking Management Group meets on the second Thursday of every month at 1200 Third Avenue, San Diego, CA 92101 in the fourth floor conference room.
