₄. a. Incentives

4.a.1. Flatirons Bank - Flatirons Bank purchased 428 Kimbark St. building. They are applying for a Façade Grant to support improvements to the exterior including new windows, doors, tiled overhang and paint. They are also making improvements to the interior. Their total investment in building (interior and exterior) is \$292,000. The total eligible Façade Grant cost is \$37,251.04 and they are requesting the 25% reimbursement of \$9,312.76.

Recommended Motion: Approve the Façade grant for \$9,312.76.

4. a. 2. 137 Main St - Longmont Liquors - Longmont Liquors at 137 Main St. is applying for a Façade Grant to cover exterior improvements to their building at 137 Main St. A vehicle recently hit and damaged the building during a traffic accident. They are applying for a Façade Grant to cover the exterior repairs/improvements to the building which include new wall, siding, window, door and paint. Their total investment in the improvements (interior and exterior) is \$109,500 and the total eligible façade grant cost is \$43,810 and they are requesting the maximum reimbursement of \$10,000.

Recommended Motion: Approve the Façade grant for \$10,000.
