### 4. a. Retail Conversion Grant - Juniper Goods

Juniper Goods will be leasing the space at 659 4<sup>th</sup> Ave. They will be opening a coffee shop and lifestyle retail store. The interior/exterior has already been updated by the property owner, Greeley Sachs (exterior paint and interior floors). Juniper Goods will be updating more of the space for their business. They are requesting a Retail Conversion grant to support costs related to updating the plumbing and electrical and building a new coffee, kitchen and wine bar. Their total eligible grant costs are \$35,600 and they are requesting 25% reimbursement of \$8,900. LDDA's portion would be \$5,934 and the LEDP portion of this grant would be \$2,966 and they have approved their contribution to the grant.

**Executive Summary:** Imagine The Possibilities (ITP) completed its four-day intensive study of the LDDAs retail district on August 21 – 24. The days were spent with a tour of the entire district, visits with stakeholders, shopping/visiting with retailers, attending Unity in the Community and independent investigation. A report will be submitted within 30 days, including a framework for 6, 12 and 18 month timeframes.
