

## BID ADDENDUM #2

PROJECT: Spring St. (US-19/SR-9) Streetscape Project ATLDOT PI: 3000

This Addendum shall be incorporated into the contact documents. The Project Manual and Bidding Documents shall be altered as noted below.

### Questions and Answers

1. **Question:** Landscaping sheets are calling for 1 gal Creeping Lilyturf, while the quantity details are calling for 4” pots. See sheets 85 and 94 respectively. Which one is correct?

**Answer:** The Creeping Lilyturf quantity is for 4 inch pots. The bid quantities do not change. Project plan sheets 29-0001 through 29-0004 will be revised to reflect 4 inch pots where applicable for the final plan sheets issued at time of project award.

2. **Question:** Will night work be permitted for the project?

**Answer:** Contract specifications and plan details outline traffic control compliance. Any special traffic control request outside of these requirements are to be submitted to the appropriate agencies (City of Atlanta and/or GDOT District 7) and Midtown Alliance for approval consideration.

3. **Question:** Will there be any special coordination required or cost be anticipated for Buford Spring Connector GDOT work?

**Answer:** The work specified in the plans at this intersection is already approved with plan work activity cost reimbursement specified (pay items). No additional coordination required with GDOT for this project work at this intersection other than contract traffic control submission.

4. **Question:** City of Atlanta permits be picked up by the contractor or Midtown Alliance?

**Answer:** Contractor is required to submit, coordinate and receive permits required by the City of Atlanta, Midtown Alliance does not submit or receive these for the contractor.

5. **Question:** The Bid Documents has typos on paged 26 & 198 – Juniper Streetscape

**Answer:** Please see revised Section 00480 – Oath of Successful Bidder. Typo is acknowledged in Section 001705 – Contract Closeout but not reissued. Any other typos referencing other projects’ names is intended to state “Spring Street (US-19/SR-9) Streetscape.”

6. **Question:** Drug Free WorkPlace - Our understanding as shown is to send pages 25 & 26 to each subcontractor so they can list their name, but there is not a place for a subcontractor signature.

**Answer:** Only the Prime Contractor is to complete Section 00480 – Oath of Successful Bidder.

7. **Question:** Please confirm channelizing traffic device is per gdot 4961 temporary Concrete Barrier.

**Answer:** The project plans do not specify the use of temporary concrete barrier walls. The contractor is responsible for complying with all MUTCD, safety and standard guidelines, specifications, etc.

This bond shall not only serve to guarantee the completion of the work on my part, but also to guarantee the excellence of both workmanship and materials until the work is finally accepted, as well as to fully comply with all the laws of the State of Georgia.

### II. CONFLICT OF INTEREST

By signing and submitting this Oath I hereby certify that employees of this company or employees of any company supplying material or subcontracting to do work on this Contract will not engage in business ventures with employees of Midtown Alliance nor shall they provide gifts, gratuities, favors, entertainment, loans or other items of value to employees of this organization.

Also, by signing and submitting this Oath I hereby certify that I will notify Midtown Alliance through its Project Manager of any business ventures entered into between employees of this company or employees of any company supplying material or subcontracting to do work on this Contract with a family member of Midtown Alliance employees.

### III. PROHIBITED SOURCES' (CONTRACTORS) ETHICS PLEDGE

I hereby certify that employees of this company or employees of any company supplying material or subcontracting to do work on this Contract will not offer money or a personal gift, meal, ticket, travel, entertainment, or other gratuity as defined per City of Atlanta Code Section 2-801 to any Midtown Alliance or City employee or official who has interest in this Bid.

### IV. DRUG FREE WORKPLACE

The undersigned certifies that the provisions of Code Sections 50-24-1 through 50-24-6 of the Official Code of Georgia Annotated, relating to the "Drug-free Workplace Act", have been complied with in full. The undersigned further certifies that:
