NOTICE CALLING FOR PROPOSALS

Downtown Boise Foundation (DBF), a 501(c) 3 nonprofit, will accept proposals for Alive After 5 Beverage Sponsorship at their office, 816 W. Bannock St, Ste 310, Boise, Idaho 83702 until 4:00 p.m. local time on February 2, 2024. Proposals may be emailed to shuitt@downtownboise.org, subject line: **AA5 Beverage RFP.** Emailed proposals in pdf format will also be accepted until 4:00 p.m. local time on February 6, 2024.

The Downtown Boise Foundation Board of Directors and staff of Downtown Boise Association, acting on behalf of the DBF (hereafter collectively referred to as DBF), is soliciting proposals from respondents to provide Beverage Sponsorship for the Alive After 5 Summer Concert Series, beginning in the 2024 summer season. Contained within are specific objectives which will be required of the awarded respondent. DBF shall retain the ability to revise this scope as necessary.

The resulting agreement's duration is expected to be a two-year sponsorship agreement with an additional one-year option.

A committee from DBF and from the DBA Board of Directors and staff will evaluate submissions to the request and will consider all qualified respondents. Those respondents which are determined to be best qualified to undertake the services required under this Request for Proposal may be invited to make a presentation to the committee. Further information may be provided to the prospective respondents after the initial selection. We reserve the right to interview some or all the respondents.

Within sixty (60) days after the Proposal opens, a contract may be awarded by DBF to the respondent deemed most responsive. DBF does not discriminate based on race, religion, sex, national origin, marital status, age, physical handicap, ownership by women or minorities, or sexual orientation.

AWARD: DBF reserves the right to make an award based on the proposal which is most responsive to its needs. The resulting sponsorship agreement duration is expected to be a two-year agreement with an additional one-year option. The agreement will not be an automatic renewal and is dependent on DBF approval for each subsequent year.

ABOUT THE SPONSORSHIP PROPOSAL

The 2024 season of Alive After 5 runs seven consecutive weeks every Wednesday from June 26 to August 7, approximately 5:00pm – 8:00pm. Subsequent summer seasons will also run on Wednesdays in June through August, with the number of concerts and if they will be consecutive to be decided early each year.

In addition to being selected as the preferred beverage provider, the Beverage Sponsor will receive a comprehensive marketing package which may include radio, print, television and social media promotions, on-site signage, and live PA mentions at the event.

As a local event, DBF would like to showcase local beverage makers as best as possible, while also having a diverse selection. A minimum of one local beverage maker must be included in the beverage lineup, with a preference for more. To increase the sustainability of Alive After 5 events, all beverages must come in a recyclable container, i.e. aluminum or recyclable plastic (type #1 or #2.) No draft products or products that require a cup. The Beverage Sponsor will agree to coordinate product options with DBA staff prior to each summer's event season, and prior to securing products.

Please include the following beverage categories and pricing for each:

- Local beers
- Local wines (no red wines)
- Local non-alcoholic beverages
- Craft beer
- Special beverage products
- Malt beverage / canned cocktail, etc.
- Other non-alcoholic beverages, at least one being an electrolyte drink

Please include an example product lineup and pricing for each: For your consideration, please reflect the DBF selecting to have 4-5 beer options, 2 malt/seltzer/canned cocktail options, 1-2 wine options, and a minimum of 1-2 non-alcoholic options aside from water with a preference for more for the season.

In addition to the proposed product mix and sponsorship package details, please include in your proposal your plan (including any additional costs) for the following:

- Wristbands
- Signage
- Weekly tasting booth activation
- Any other marketing; point-of-sale materials, promotions, etc...
- Ice
- Refrigerated truck to hold product at each event
- Number of employees dedicated to weekly event: loading bars, keeping beverage products and ice stocked, unloading bars at end of event, etc.
- On-site equipment: Cooler bins/bars to serve product
- Any sustainability efforts/initiatives
