## APPLICATION FOR BOARD MEMBERSHIP

The Pike District Partnership is the advocacy and marketing engine that fosters connections and amplifies community voices to promote economic opportunities with a central purpose to position the Pike District's success as North Bethesda's Urban Core.

The Pike District Partnership is seeking applicants for a Board of Directors. The Board will consist of voting Directors who shall be selected from the following member categories:

- Up to Four Directors shall be representatives of **Large Property Owners** owning four or more acres. Annual Dues: \$5,000
- Up to Three Directors shall be representatives of **Small Property Owners** owning four of less acres. Annual Dues: \$2,500
- Up to Four Directors shall be representatives of **Large Business Owners** with more than 40 full time employees. Annual Dues: \$500 (*\$400 of the annual dues is covered by a grant from Montgomery County for the first two years*).
- Up to Four Directors shall be representative of **Small Business Owners** with less than 40 full time employees. \$250 (*\$200 of the annual dues is covered by a grant from Montgomery County for the first two years*).
- Up to six shall be **Resident Members** who reside in the Pike District. No Annual Dues.
- Up to three shall be **At Large Members**. Annual Dues: \$250.

### **Expectations for Membership on the Board of Directors:**

- Attend three to four regular monthly Board, committee, or special meetings. Board meetings are held the last Thursday of each month.
- Be present and volunteer at one-third of Pike District Partnership sponsored events.
- Attend the Annual Planning Session.
- Participate in policy discussion and decisions affecting the Pike District Partnership and North Bethesda.
- Accept responsibility for assignments and offer suggestions on programming and/or operations.
- Maintain matters of confidence.
- Meet financial requirements as required per applicable membership category.
- Each Board Member is responsible for the annual fees outlined above and will serve a three-year term.

*Applications will be accepted and considered from October 1 to October 31, 2023.*
