- Candy & free items may not be thrown out until you have reached the Beale Street neon archway sign.

In consideration of being permitted to participate in such activity the participant does hereby release and forever discharge the Downtown Memphis Commission, Beale Street Merchant Association and all other parade sponsors, and the City of Memphis, its Officers, Officials, Employees and Agents, jointly and severally from any and all actions, causes of actions, claims and demands for, upon or by reason of any others in consequence of participating in the activities. This waiver and release expressly includes any action, cause of action, claim or demand based upon any act, omission or negligence by the Downtown Memphis Commission, Beale Street Merchants Association, other parade sponsors and the City of Memphis.

This release extends and applies to and also covers and includes, all unknown, unforeseen, unanticipated and unsuspected injuries, damages, loss and liability, and the consequences thereof, as well as those now disclosed and known to exist. The provisions of any state, federal, local or territorial law or statute providing in substance that releases shall not extend to claims, demands, injuries or damages which are unknown or unsuspected to the person executing such release at the time of execution, are hereby expressly waived.

I hereby agree on behalf of my heirs, executors, administrators, and assigns, to indemnify the Downtown Memphis Commission, Beale Street Merchant Association, other parade sponsors, and the City of Memphis, jointly and severally, and to hold the same harmless from and against any and all actions, claims, demands and liabilities, loss, damages and expense of whatever kind or nature, including attorney fees, which may at any time be incurred by them or claimed against them by reason of my participation in the parade. This holds harmless and indemnity provision expressly includes any action, claim or demand based upon any omission or negligence by the Downtown Memphis Commission, Beale Street Merchant Association, other parade sponsors and the City of Memphis and its Officers, Officials, Employees or Agents.
