#### Call to Order

Commissioner Van Turner joined the meeting via conference call and Chairman Person called the meeting to order at 12:09 pm.

## Chairman Person called for agenda item II: Approval of Minutes

#### Chairman Person called for agenda item III: Affiliate Board and Committee Updates

Chairman Person updated the board on all DMC affiliated boards activity and discussed a great start to 2017 including the Board Retreat at Alfred's.

#### Chairman Person called for agenda item IV: Bicentennial Gateway Project Update

Mr. Paul Young, Director of City of Memphis Division of Housing and Community Development, presented an update on the redevelopment of the Pinch neighborhood, as well as the more comprehensive gateway project.

#### Chairman Person called for agenda item V: Beale St. Management Update

Mr. Patterson discussed the option of the Downtown Memphis Commission serving as a more permanent manager for Beale St. proposing that with a more long term agreement, the DMC could have a more long term approach. year or more. Ms. Pesce seconded the motion and it was approved by the board with Representative Cooper declining and Ms. Massey abstaining.

#### Chairman Person called for agenda item VI: President's Report

Mr. Patterson discussed the DMC's strategic goals, priorities, principles, and a new Downtown Dashboard which updates the board on downtown metrics and focus areas. Additionally he discussed the new outline of DMC Board Meetings which will include a monthly speaker that is active in working towards Downtown Memphis, such as Mr. Paul Young.
