A few major issues are vehicular related issues (cruising, speeding & reckless driving), safety & security on Beale Street, unwanted activity on parking lots and garages, loud carriages and pedal pubs, scooters posing a nuisance by driving recklessly, and the lack of youth activities. After the presentation Deputy Chief Paul Wright and Assistant Chief Donald Crowe led an open discussion and answered several questions.
