# Thursday, September 23, 2021, 9AM 114 North Main Street

Benjamin Orgel determined that a quorum was present and called the meeting to order at 9:03 AM. Christine Taylor called roll for board members to confirm quorum. After reviewing meeting protocols, Chairman Orgel called for approval of the minutes from August 25, 2021 meeting. Joann Massey motioned to approve the minutes as presented, Demar Roberts seconded the motion, after roll call vote, the motion passed unanimously.

### Chairman Orgel called for agenda item IV: Financial Update

Penelope Springer presented monthly financial report.

### Chairman Orgel called for agenda item V: 114 North Main Street

Brett Roler presented the request for 114 North Main renovations approval to renovate tower floors 2-6 for use as leasable office space. The total area of the tower to be renovated is approximately 7,891 sq. ft. The design plans call for the reuse of the existing historic stair and a new elevator installed within the existing historic elevator shaft. Floors 2-6 will be brought up to a "vanilla-box" condition ready for an open office use. Tenants would be responsible for any tenant improvements if individual offices or additional interior partition walls are desired. Board action is needed to enter into a lease for use of its current office space. Arch Inc. has been engaged as the architect, and Nickson General as the general contractor. Construction is estimated to begin in Q4 2021 and could be complete in Q3 2022. Penelope Springer explained the financing structure of the project and Paul Young explained why staff feels this is the right time to renovate.

Julie Ellis motioned to approve the request as presented, Williams Brack seconded the motion, after roll call vote, the motion passed unanimously.
