Applicant's Request:	South City Good Neighbor Grant up to \$50,000.		
Applicant's Request: Project Description:	 The subject property is located on the northwest corner of South Second St. and Talbot Ave. The 10,498 sq. ft. site contains three structures. The main office, fronting South Second St., was built in 1947 as a single story, 4,128 sq. ft. building. A modular structure, used as the WLOK sales office, faces Talbot Ave. A third storage facility is located towards the back (west) of the parcel and faces Mulberry St. "In 1977 WLOK became Memphis' first African-American owned radio station. Established on this site, Gilliam Communications' WLOK is a family-oriented format on which many of the nation's top African-American leaders have appeared. Several of the nation's leading disc jockeys started here. WLOK's community involvement includes college scholarships and the renowned WLOK Stone Soul Picnic. The station's call letters, WLOK-AM, are 'A Family Tradition.'" – Tennessee Historical Commission Landmark, located on site. The applicant plans to begin renovation work following approval of grant funding and DRB approval.

Estimated Budget: The South City Good Neighbor Grant is a special program offered by the Downtown Memphis Commission (DMC) and the Center City Development Corporation (CCDC) in partnership with the City of Memphis Division of Housing and Community Development (HCD) and the South City Choice Neighborhood Initiative (CNI). This grant is designed to help commercial property owners and businesses in the South City Neighborhood make exterior improvements to their property.

The South City Good Neighbor Grant is for exterior work only and provides up to 90% of the total project cost up to \$50,000.

Design Review:

This project will be reviewed at the May meeting of the Design Review Board (DRB).

EBO Program: Any project that is awarded financial incentives from the Downtown Memphis Commission (DMC) shall include a best faith effort to reach no less than 25% participation by minority and/or women owned businesses (M/WBE) in the project's development cost (design and construction hard costs). Compliance with this Equal Business Opportunity (EBO) Program is a closing requirement. If the requirements of the

EBO Program are not met, the CCDC will cancel the incentive.

Based on the estimated budget, a 25% level of M/WBE inclusion is approximately **\$16,217.**

Staff Evaluation: The South City Good Neighbor Grant is designed to help South City commercial property owners and businesses strengthen or restore the character of important places within the community with high-quality improvements to the exterior of their property. A secondary goal of the grant is to help new and existing businesses succeed by enhancing their curb appeal in ways that might not be possible without assistance. This project is aligned with the goals of the DMC and the Good Neighbor Grant to improve commercial property values and encourage property investment within the South City Neighborhood.

> Staff is supportive of approving a South City Good Neighbor Grant for this project. The proposed improvements bring added character and vibrancy to an area of connectivity between the South City neighborhood and the activity along South Main. The changes to the building and landscape enhance the pedestrian experience along three different streets. The applicants hope for the project was to add colorful, inviting colors, decrease garbage accumulation, and increase tourist interest in the site. The proposed improvements meet the applicant's goals as well as our intention for the program at the DMC.

Staff Recommendation:Staff recommends approval of a South City Good Neighbor
Grant in an amount up to \$50,000 based on approved
receipts and subject to all standard closing requirements.
