Existing Property Condition: First initial renovation of interior building was completed in late 2021. We opened to the public in October 2021, without finishing part of the exterior renovations for a beer garden. The current conditions of the existing property: un-level surface area from breaking and grass growing over previous asphalt; old fencing/gate; and old gas meter with new meter attached. A new production emergency exit was added with concrete stairs; a new wooden fence was installed to cover new air coolant machine; and a new storefront door and ADA compliant ramp was installed before opening to public. Currently, we have our food trucks pull into the space while we are open and lock them inside the gate.

Future Use of Proposed Property: We are proposing a fully fenced/gated in new covered beer garden space (entire area will be concrete, except the gravel for food trucks and dog park) and tables, a dog park (astroturf), gravel/chat area for food trucks to pull into. Customers only have access into beer garden from the interior of the brewery; large gate will be opened up for food truck to come in and park (on gray area of plan, to be covered in gravel/chat) and then locked behind; small gate will be an emergency exit gate for customers. Stage is future buildout, will be a concrete pad for now.

Exterior Improvements: Covered concrete patio with tables, 3 foot fenced (black vinyl coated commercial grade chain link) in dog park, new fencing (black vinyl coated commercial grade chain link), new gate (black vinyl coated

commercial grade chain link), cover existing gas meter with wooden fence/gate for maintenance, new potted landscaping.


