

TERMS AND CONDITIONS

NO PURCHASE NECESSARY. VOID WHERE PROHIBITED BY LAW.

This Downtown Restaurant Gift Card Promotion (“Gift Card Promotion”) begins April 10, 2020 and ends April 30, 2020 (“Contest Period”). At approximately 9:00 a.m. each day during the Contest Period, Downtown Fort Worth, Inc. will post on Facebook a post (“Daily Post”) regarding support for a specific downtown Fort Worth restaurant (“Daily Restaurant”).

ELIGIBLE ENTRIES (AS DEFINED BELOW) MUST BE RECEIVED ON OR BEFORE 8:45 AM ON THE DAY FOLLOWING THE DAILY POST (“SUBMISSION DATE”) IN ORDER TO BE ELIGIBLE TO BE INCLUDED IN ANY PRIZE DRAWING.

This Gift Card Promotion is open to legal residents of the State of Texas, 18 years or older at the time of entry, and is void where prohibited. You may enter the Gift Card Promotion with an On-line Entry commenting or replying to the Daily Post on Facebook as directed.

Provided they are submitted on the applicable Submission Date, each person submitting, an accepted On-line Entry (“Eligible Entry”) is eligible to be included in a drawing to be conducted each day immediately following each Daily Post or other date selected by Downtown Fort Worth, Inc. (“Drawing Dates”) during the Contest Period. Winners will be selected using *Woodbox*, *Comment Picker*, or other third-party resource adapted to select winners from among all Eligible Entries (excluding prior winners) submitted on the Submission Date immediately prior to the applicable Drawing Date. The odds of winning a prize will depend upon the total number of Eligible Entries for the applicable Submission Date. Entries will not be acknowledged or returned. Winners will be announced on Facebook at approximately 9:00 a.m. on each Drawing Date. Winners will be advised as to where to pick up their prize. A valid ID matching the name provided via contest entry must be shown to claim the prize. Each of the prizes will be a gift certificate/gift card from the applicable Daily Restaurant, each certificate having a face value of \$25, \$50, or \$100. A total of \$3500 will be given away during the Contest Period. Each entrant is limited to one prize. Prizes must be redeemed on or before December 31, 2020.

Employees of Downtown Fort Worth, Inc. (“DFWI”), its sponsors and prize providers and their immediate family members and/or those living in the same household of each, are not eligible to enter or win.
