- In accordance with the provisions of Article VIII, Section F of the BID bylaws, Notice of the Annual Meeting, the FY 2019 Board of Directors slate, and ballots were provided to voting members by mail on April 24, 2018.
- Ten-percent of voting members need to be present in order to constitute a quorum.
 There are 386 votes entitled to be cast, thus 39 votes constitute a quorum. A quorum is present.

- Members unanimously approved the bylaws revisions.
